I refer to your email dated 16 June 2023 in which you asked for information in relation to immigration charges. Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

"I am writing today on behalf of the Policy Team at the Law Centre for an inquiry relating to charges of assisting unlawful immigration/facilitation. We have an interest in understanding how many people in the last 3 years have been charged under Section 25 of the Immigration Act 1971 in Northern Ireland".

In response, please note that the PPS is unable to provide data in respect of individuals charged as this is not a matter for the Service. However, we can advise that for the three financial years from 2020/21 to 2022/23, prosecution decisions were taken against 5 persons in relation to the specified offences. The list of offences considered for the purposes of this query can be found below at **Table A**.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review in accordance with our review procedure. You should do this as soon as possible or in any case within two months of the date of this response and you can do so by writing to the Head of Policy and Information, Public Prosecution
