I refer to your correspondence dated 29 July 2024 in which you requested information on domestic abuse and stalking offences. Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

- 1. "Domestic abuse cases, number of files that have come through to the PPS since 2022 and then the breakdown of the number of prosecutions relating to those files.
- 2. Number of files that have come through to the PPS in relation to the Stalking Offence and the breakdown of the number of prosecutions relating to those files.
- 3. Is there anyway of breaking down the number of repeat cases in relation to domestic abuse in relation to the relationship between perpetrator and victim?
- 4. Is there any way of giving us data on the relationship between perpetrator and victim and if it is an intimate partner?"

In response to question 1, please see Tables 1 and 2 below which provide the numbers of files / suspects received and decisions issued in cases with a PSNI domestic abuse flag for the period between 1 January 2022 and 28 July 2024.
