

I refer to your email dated 2 May 2024 in which you requested information relating to sexual offences. Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

- 1. The total number of sexual offences case files received by the PPS annually for the last 5 years.
- 2. The total number of sexual offences case files that met the test for prosecution for the last 5 years.
- 3. The conviction rate for sexual offences for the last 5 years.
- 4. The total number of sexual offences cases currently awaiting trial in Northern Ireland.
- 5. The average wait time for a sexual offences case to make it to court.

Please be advised that figures for the financial year 2023-24 cannot be provided as they will form part of an upcoming Official Statistics publication (due for release in Autumn 2024). Therefore the responses below focus on the five financial years (1 April to 31 March) from 2018/19 to 2022/23.

In response to question 1, please see Table 1 below which provides data in respect of the numbers of files received by PPS involving a sexual offence.

In response to question 2, please see Table 2 below which details the numbers of decisions issued in cases involving a sexual offence, and the percentage where the Test for Prosecution was met.

Table 2: Prosecutorial Decisions Issued by PPS (No. of Suspects) in Cases involving Sexual Offences and % where the Test for Prosecution was Met

In respect of question 3, please see Table 3 below which details the conviction rates (in the Magistrates' and Crown Courts) for sexual offences.

In response to question 4, please be advised as of 2 May 2024 there are 139 suspects currently listed for trial. However, it should be noted that this figure is subject to change as court listings can be added and amended by the Northern Ireland Courts and Tribunal Service (NICTS) at any given time.

In response to question 5, please be advised that PPS does not record this data, therefore, in terms of the Freedom of Information Act 2000, we can confirm that under Section 1(1)(a) of the Act, the PPS does not hold the requested information.

However, while it is not possible to produce data for the average time taken for a sexual offence case to go to court, please see Table 4 below which provides the median number of days between receipt of file by the PPS and issue of decision (by type).

^{*} Prosecution in the Crown Court. Includes time taken for the preparation of committal papers which contain the evidence to be presented to the Crown Court. It may also include time for consideration of duties of disclosure / any applications to be made to the court.

Note: All decision types include the time taken for police to respond to 'Decision Information Requests' (i.e. requests for further information).

If you are dissatisfied in any way with the handling of your request, you have the right to request a review in accordance with our review procedure.
